Objectives and investment policy

The key features of the sub-fund are as follows:

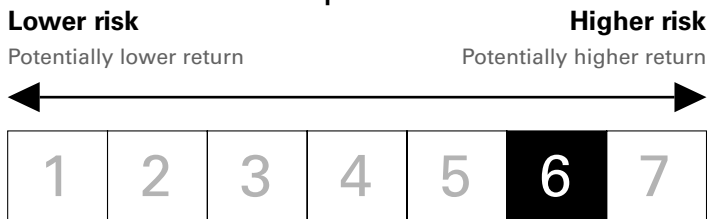
- The sub-fund aims to outperform its reference indicator over a period exceeding five years and generate long-term capital growth.
- This Sub-Fund is an actively managed UCITS. The investment manager has discretion over the composition of its portfolio, subject to the stated investment objectives and policy. The Sub-Fund's investment universe is at least partly derived from the Reference indicator. The Sub-Fund's investment strategy is not dependent on the Reference indicator; therefore, the Sub-Fund's holdings and the weightings may substantially deviate from the composition of the Reference indicator. There is no limit set on the level of such deviation. The reference indicator is the Stoxx 600 NR (EUR) index.
- The sub-fund is a European equity sub-fund invested mainly in equities of EU Member States and, within the limit of 10%, in equities of non-EU countries or candidates for accession as well as Turkey and Russia. The assets which are not invested in equities of the countries specified above shall be preferably but not automatically invested in international transferable securities. The fund can invest up to 10% of the net assets in bonds with a rating below investment grade.
- The manager may use Relative Value strategies as performance drivers, looking to take advantage of the relative value between different instruments. Short positions may also be taken through derivatives.
- This Sub-Fund has (E) environmental and (S) social characteristics in accordance with article 8 of the Sustainable Finance Disclosure Regulation ("SFDR"). The Sub-Fund applies either best-in-universe or best-efforts approach and negative, relative and positive screening. Thereby the Sub-Fund's investment universe is actively reduced by at least 20%. Examples of ESG criteria include: (E) carbon emissions data, (S) human capital policies, (G) minority shareholder treatment. The Sub-Fund's sustainability risk may differ from the sustainability risk of the Reference indicator. The Sub-Fund aims to achieve carbon emissions 30% lower than the reference indicator as measured by carbon intensity.
- The sub-fund invests, on an ancillary basis, in money market instruments, treasury bills, fixed and/or floating rate bonds, government and/or corporate bonds and inflation-linked

Eurozone and/or international bonds.

Other information:

- The sub-fund uses derivatives for hedging or arbitrage purposes, or to expose the portfolio to the following risks (directly or via indices): currencies, bonds, equities (all categories of capitalisation), ETFs, dividends, volatility, variance (the latter two categories for up to 10% of net assets) and commodities. The derivatives available are options (vanilla, barrier, binary), futures and forwards, swaps (including performance) and CFDs (contracts for difference) on one or more underlyings.
- Up to 10 % of the net assets may be invested in contingent convertible bonds ("CoCos"). CoCos are regulated subordinated debt instruments that are complex, but consistent in nature. Please refer to the prospectus for more information.
- The sub-fund may invest up to 10% of its net assets in units or shares of UCIs.
- This sub-fund may not be suitable for investors planning to withdraw their investment within five years.
- Investments may be redeemed each business day on request. Subscription and redemption requests are centralised on each NAV calculation and publication day before 18:00 CET/CEST and are executed on the next business day using the previous day's NAV.
- This unit is an accumulation unit.

Risk and reward profile

The charges paid are used to cover the costs of running the sub-fund, including the costs of marketing and distributing units. These charges reduce the potential growth of the investment.

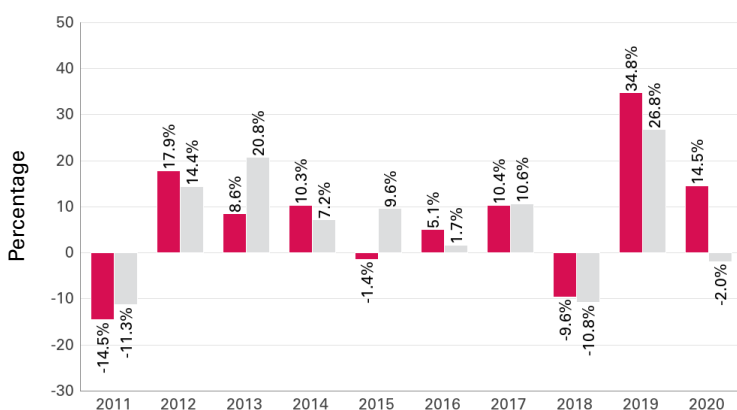
