What is this product?

Objectives

The Product's sustainable investment is to provide long-term capital growth by investing in European equities securities through an investment process that fully integrates sustainability considerations. The MSCI Europe Dividend Net Index is representative of the European Equity markets. This Product may not be appropriate for investors who plan to withdraw their money within less than 5 years. The Product invests at least 80% of its net assets in equity securities of companies based in Europe and seeks to invest in companies with exposure to economic tailwinds from the long-term transitions affecting the global economy over the next decade or longer (major demographic, technology, environmental and governance transitions). The Product implements a sustainable investment approach by seeking to invest in companies that contribute to the achievement of United Nations' Sustainable Development Goals (the "SDGs") through their products, services and/or practices.

Intended retail investor

The Product is suitable for institutional and retail investors who are looking for an exposure to the European equity markets via investment in companies whose businesses include activities related to sustainable investment themes; are interested in investing in a socially responsible fund; can afford to set aside capital for at least 5 years (long term horizon); can accept temporary and/or potential capital losses; and can tolerate volatility.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Performance Scenarios

What are the costs?
