What is this product?

Objectives

The Sub-Fund has a sustainable investment objective which is to allocate the capital towards sustainable economic models with environmental and/or social benefits by investing in companies providing solutions to address mainly environmental issues. The Sub-Fund will seek to invest in companies, listed on European stock exchanges, while systematically including Environmental, Social and Governance ("ESG") considerations, with financial performance measured against the MSCI Europe Net Dividends Reinvested Index over the recommended minimum investment period of 5 years. The Investment policy of the Sub-Fund is to invest in European equity securities of companies whose business activities include the development, production, promotion or marketing of technologies, services or products that contribute to environment protection. It mainly invests in European companies active in the renewable energy, transition energy, energy efficiency and natural resources management such as agricultural/food and water production cycle.

Intended retail investor

The Product is suitable for institutional and retail investors who are looking for an exposure to the equity markets via investment in stocks; are interested in investing in a socially responsible fund; can afford to set aside capital for at least 5 years (long term horizon); can accept temporary and/or potential capital losses; and can tolerate volatility.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.
