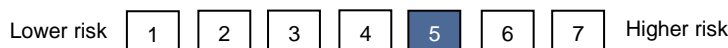
The Fund aims to achieve a combination of growth and income by investing in companies listed on Chinese stock exchanges, which adhere to the abrdn Sustainable Equity Investment Approach. The Fund aims to outperform the MSCI China A Onshore Index (USD) benchmark before charges.

Intended retail investor

This Fund holds China A-Shares and may suit investors seeking capital growth opportunities through equity investments. The Fund is likely to be used as a complement to a diversified portfolio. Due to the additional risks associated with investments in China, the investor should have a long-term investment horizon. Investors should be aware that the Fund's RQFII investments will be limited by the RQFII quota awarded by the CSRC. This may result in a need to close the Fund to further subscriptions as provided for under this Prospectus. Investors should be aware of the particular dealing arrangements which may be applicable to the Fund, which are referred to in this Prospectus.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years.

We have classified this product as 5 out of 7, which is a medium-high risk class.

Performance Scenarios

What are the costs?
