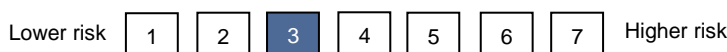
The sustainable investment objective of the Sub-Fund is to invest principally in non-investment grade rated fixed income instruments that generate environmental and/or social benefits provided that such sustainable investment does not significantly harm any of the sustainable objectives as defined by EU Law and that the selected issuers follow good governance practices. The Sub-Fund will invest in fixed income securities issued by companies worldwide mainly denominated in euro including notably conventional bonds green bonds green & social bonds social bonds while systematically including Environmental Social and Governance (ESG) considerations with an objective to outperform the ICE BofA Merrill Lynch Euro High Yield BB-B Index over the recommended minimum investment period of 3 years. This index represents primarily sub-investment grade fixed income bonds issued by public or private corporations. The Investment Manager aims at building a diversified portfolio of fixed income securities based on ESG criteria and fundamental analysis of credit quality and valuation. It aims at selecting fixed income securities and/or issuers whose purpose is to finance projects with a positive environmental and/or social impacts or that contribute to the sustainable transition throughout their activities. It also implements a top-down and broader approach on fixed income markets depending on investment team's macroeconomic views.

Intended retail investor

The Fund is suitable for investors who are looking for a diversification of their investments in European fixed income securities; are interested in investing in a socially responsible fund; can afford to set aside capital for at least 3 years (medium term horizon); and can accept temporary losses.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact our capacity to pay you.

These risks are materially relevant to the fund but are not captured by the SRI counterparty risk liquidity risk credit risk.
